The Other RAACA SCHOLARSHIPS

The current situation relating to the RAACA Victorian Branch Scholarships as it appears regularly in Track

"One of the benefits your Association provides are the scholarships available to eligible children commencing or completing their Secondary education. Applicants must be the children of a financial member; unfortunately, due to financial constraints, grandchildren are not eligible for either scholarship at this time."

"The Victorian Branch Scholarship is currently **\$150.00 per year** for the first two years of secondary school. Applications should be forwarded to the Secretary with proof of attendance by **28 February in the first year of qualification. A follow up application is required for the second year**. You must have been a financial member of the RAACA for a **minimum of five years to apply**."

A brief history of the RAACA Victorian Branch Scholarships (1974 - 1999)

The "Welfare Patriotic Fund"

The RAACA Victorian Branch was authorised to establish a "Welfare Patriotic Fund" on the 23rd August 1971 (Authority No. 3268), the money to start this fund were provide by transferring monies originally raised by members from 1946 to 1953 and placed in a registered "Building Patriotic Fund" established on 1st November 1948 (Authority No. 3268). This money was accumulated with the intention of "erection or purchasing club rooms" for the RAACA Victorian Branch members.

By 1964 it was recognised by the Committee that the funds accumulated were not sufficient to meet the stated objective of establishing clubrooms. This fact plus the decline in membership and the introduction of less restrictive liquor licensing laws (eg. 6.00 to 10.00 pm public bar closing times) caused some concern as to the viability of licensed club rooms.

The membership of the RAACA Victorian Branch in 1953 was 2000, in 1966 approx. 80/100, with an increase to 380 as at 31st December 1970. With this new membership it became clearer that these funds should be available provide some benefits to members from a new generation of Armoured Corps soldiers, those who served in the Fifties and Sixties. However the restrictions on having the money in a "Building Patriotic Fund" prevented them being used in any way other than for clubrooms. In January 1970, a start was made to have this position changed. The efforts of Gordon Arthur DAVIDSON and supported by Victor CHAPPLE & John Gerald NORRIS resulted in gaining approval on 10th October 1972, by order of the Governor in Council, to have these funds transferred to the "RAACA Victorian Branch Welfare Patriotic Fund" and available for welfare purposes.

Welfare Benefits

The availability of a source of funds for welfare purposes allowed the RAACA Victorian Branch to review the needs of eligible members. Whilst there was occasional calls for welfare assistance during financial crises, it was identified that there was a far wider need for support of members to educate their children. This is not normally perceived as a financial crisis issue, but one were the members were financially pressured by education costs. A payment towards these expenses would support the improvement in the financial situation for a member.

Scholarship Awards

From the archives.

The proposal to establish a scholarship was made by Charles H. Walsh in a letter dated 30/8/1973 to the Secretary and minuted on the 5th November 1973.

The call for 1974 applications and notification of eligibility criteria were published in "Track" December 1973.

This is the "call for applications" as it appeared in that issue of Track, at the bottom of Page 4 & 5. VICTORIAN SCHOLARSHIPS Your Committee has elected to grant scholarships to dependents of FINANCIAL OR DECEASED members of this Branch of the Association, and whilst time is short for 1974, we hope to have everything completed by the commencement of the school year. Here are the details. - Tenure - It shall be for the first two years of Secondary or "Righer' Education. ... 5 ... 2. Full name and age of scholar. 3. Present and proposed schools. 4. Last (1973) Head Haster's or Teacher's name. 5. Standard now achieved. 6. Closing date 4th February 1974, (TO BE LANDED IN AT THE A.G.H.) 7. Applications to be submitted to the Trustees of the Association, P.O. Box 13, CAMBERWELL, 3124. For future years, advice will be given earlier in the year and applications will probably close before the end of the school year.

The RAACA Victorian Branch has offered financial support to members, for the past 25 years, in assisting them to meet the cost of education of their children in the first two years of Secondary Schooling (Years 7 & 8).

Awarding Procedure

A RAACA Victorian Branch member makes an application to the Secretary, for a Scholarship each year. The Branch Committee confirms that the member meets the scholarship awarding criteria and forwards recommendations to the Trustees for payment. When the Trustees have ensured that the application of monies from the RAACA Victorian Branch Welfare Patriotic Fund are appropriate, they make a cheque payment direct to the scholarship recipients.

The Trustees have made payments totaling \$ 7850.00 over the period from 1974 to 1999. (*refer Appendix A.*)

Funding Resource Administration

Funding for these educational scholarships is through the application of monies held in the RAACA Victorian Branch Welfare Patriotic Fund.

These monies are governed by the Victorian Government "Patriotic Funds Act 1958" and supervised by the Patriotic Funds Council of Victoria.

The trustees approve the necessary funding under welfare guidelines as prescribed by the Act and must satisfy the supervisory authority with annual audited accounts.

The Patriotic Funds Council of Victoria require "prudent persons" as trustees to administer the RAACA Victorian Branch Welfare Patriotic Fund. The appointment of Trustees are prescribed in the authority to establish the Fund. (*refer Appendix B.*)

There has been a small number of changes to Trustees over the past years :

The role of the Trustees can be defined as being a part of the RAACA Victorian Branch executive, elected by the Members, but have an independent role in relation to the Patriotic Funds Council of Victoria by being governed by the Act & Regulations of the "Patriotic Funds Act 1958".

RAACA Scholarships today

With that history lesson in mind, your committee were considering the Victorian Branch Scholarship and its current suitability to the needs of our members. For their dependants, members have access to the **Brigadier F.B. Hinton, MC Scholarship** which caters for their children in the final 2 years of secondary school as well as the **Arch Finlayson Memorial Scholarship** which caters for member's grandchildren in the first year of their apprenticeship. Each of these is funded through a scholarship fund which is administered by trustees in a similar way to how the Victorian Branch Scholarship had been. In the 25-year period reported in that history, the scholarship value was \$100 and a total of \$7,850 was distributed to assist members with their children's education. In later years, when the funds had been all but distributed, the little that remained was transferred to the general RAACA accounts. There has been little to no interest in recent years and on evaluating why, the committee felt it was because the average age of members now means their children are all past the first 2 years of secondary school. The relevance of the scholarships was then considered under

the current circumstances and after some discussion it was decided that, since the second point under the "Purposes of The Association" in our Constitution says: From time to time the Association may provide welfare services to its members and secondary school scholarships to their dependants as appropriate, a scholarship should continue to be available. To achieve this aim, it was felt that the focus should now shift to provide for grandchildren of members and the best way to do this was to use the terms of the original Victorian Branch Scholarships, the criteria being as stated at the start of this article, but expand its scope. The motion then being passed by the committee as follows:

"The eligibility conditions of the 2 Victorian Branch Scholarships, (The Gordon Davidson & Charlie Walsh Scholarships) be expanded to cover grandchildren. Initially there is to be a cap of 3 of each scholarship per Association member until running costs can be assessed. The details of the changes are to be advertised in the September issue of Track, giving time for members to assess their personal situation prior to the start of the school year. The value of the scholarship is to remain unchanged at \$150 and be available to grandchildren of both ordinary and affiliate members with at least 5 years of financial membership, meaning where a family has 2 qualifying members, a total of 6 scholarships would be available."

Since the money from the original scholarship fund was transferred to the general accounts, that scheme is no longer in existence so this new scholarship will be funded through our general accounts and be administered by the committee. Having said that, it was decided to continue to honour the members who established the original scholarships and use the original names being the Gordon Davidson and Charlie Walsh Scholarships. To ensure it does not get out of hand and deplete or funds, we have kept to the original scholarship value of \$150 and added some constraints as detailed in the Motion above. This will be monitored over time and may be expanded.

The Victorian Branch Scholarship is now as follows:

The Victorian Branch Scholarship is \$150.00 per year and paid to assist with the cost of the first two years of secondary school. Applications should be forwarded to the Secretary by **28 February in the first year of qualification** in the form of a letter setting out the child's details and with proof of attendance. A follow up application is required for the second year. To apply, applicants must be the children or grandchildren of someone who has been a financial member of the RAACA for a minimum of five years.

The Brigadier F.B. Hinton, MC Scholarship which was a Federal Executive Scholarship is also administered by the Victorian Branch and currently provides **\$500:00 for each of the final two years of Secondary School**. Please send application including proof of intent to complete years 11 and 12 to our secretary by **30 September in the applicant's year 10**.

There are no scholastic results required, however proof of attendance must be provided on the relevant School's letterhead paper. **Applicants must be financial members** for a minimum of 5 years.
